



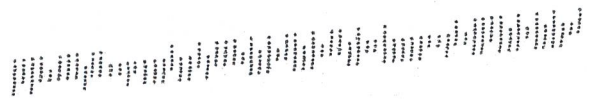

According to Building Division records, the permit for the construction described above has not had the required inspections completed, and will soon exceed the allowed time without activity, to remain in an active status.

A VALID INSPECTION performed on the permit will maintain the active status for another six (6) months without incurring additional fees.

\*\*An inactive permit is null and void. No construction or inspections can be performed. A renewal application, additional fees, and possibly code revisions would be required to continue.

**105.340      Conditions of the permit:**

**105.340.1      Permit intent.** A permit issued shall be construed to be a license to proceed with the work and not as authority to violate, cancel, alter or set aside any of the provisions of the technical codes, nor shall issuance of a permit prevent the building official from thereafter requiring a correction of errors in plans, construction or violations of this code. Every permit issued shall become invalid unless the work authorized by such permit is commenced within 6 months after its issuance, or if the work authorized by such permit is suspended or abandoned for a period of 6 months after the time the work is commenced.

**105.340.1.1      If work has commenced and the permit is revoked,** becomes null and void or expires because of lack of progress or abandonment, a new permit, revalidation of the original permit, covering the proposed construction shall be obtained before proceeding with the work.

**105.340.1.2      If a new permit, or revalidation of the original permit,** is not obtained within six months from the date the initial permit became null and void, the building official is authorized to require that any work which has been commenced or completed be removed from the building site. Alternately, a new permit may be issued on application, providing the work in place and required to complete the structure meets all applicable regulations in effect at the time the initial permit became null and void and any regulations which may have become effective between the date of expiration and the date of issuance of the new permit.

**105.340.1.3      Work shall be considered to be in active progress** when the permit has received an approved inspection within six months. This provision shall not be applicable in case of civil commotion or strike or when the building work is halted due directly to judicial injunction, order or similar process, or due to action by an environmental or archeological agency having jurisdiction. The building official is authorized to grant, in writing, one or more extensions of time, for periods not more than 3 months each. The extension shall be requested in writing and justifiable cause demonstrated prior to expiration.
